




**MINUTES OF MEETING OF REDRESSAL GRIEVANCE COMMITTEE**





	<p><u>M/S watch &amp; watch Guard Services (PVT) Ltd</u> vide their letter No. WWGS/11/25 dated 03-12-2020 stated that:</p> <p>We calculated 16% PST and 3 % WHT on minimum wages. It is further submitted that calculated 16 % GST and 3 % WHT is on minimum wages. If we calculated on gross amount, then all three companies will be out and you will have go for re-tender.</p> <p>Previously the case was discussed in the grievance committee meeting held on 9-12-2020 and committee recommended to seek advice from PPRA in response PPRA advised to follow clause 38 (2)(a) (viii) of PPRA procurement rules 2014 (Amended) in this regard</p> <p>We request your good self to kindly look into the matter and check at your end and re-evaluate the decision of Financial Evaluation committee.</p> <p>Thanking you, we remain dear sir.</p>	<p>M/ S watch &amp; Watch Guard Services (PVT) Ltd. did not meet the minimum wage criteria as per notification issued vide letter No. L&amp;M (PPRA) 10-01/2011 dated 3-12-2018. Contract for hiring of security services maybe issued in favor of M/ S Fair Security System.</p>	<p>As formula for quoting price by the bidder in not mentioned in the bidding documents issued to bidders. The bidders quoted the one consolidated rate including all applicable taxes (without mentioning the base line wage +income Tax +PST) separately According to rule 55 &amp; 38 (2) (a) (viii) of PPRA rules 2014 "Procuring agency to award the procurement contract to the lowest evaluated bidder without conflicting any other law. Therefore, Grievance committee accepted the grievance submitted by M/ S Watch &amp; Watch Guard Services (PVT) Ltd. However Grievance committee advise FEC to change the bidding documents by showing Base line wage ,Income Tax +PST separately</p>
